What: ISO 9001:2015 – The Next Generation: Highlights of a Paradigm Shift with a Focus on Context of the Organization:

The release of ISO 9001:2015 has introduced a significant paradigm shift, which will require organizations to demonstrate that these new protocols have been integrated into their quality management system. The shift from a solely quality management system to integrating processes such as strategic direction, context of the organization, leadership/planning to address risks and opportunities has presented a challenge to many organizations.

Judi Markel of ISO Advantage has registrar specific training and has conducted 3rd party transition audits. She will be presenting an inside glimpse at what auditor's will be looking for as evidence. The topic of context of the organization and how that principle can be applied to a company's quality management system will be explained, as it pertains to different industry sectors. Additionally, top management's involvement in the new Leadership principle, together with if and how it fits in with the risk based thinking and context of the organization, will also be discussed.
