- **York Hospital Has Been Designated As A Magnet Hospital**

York Hospital, a part of the WellSpan Health system, was informed on January 12, 2009 that the American Nurses Association's Magnet Commission voted **unanimously** to designate York Hospital as a Magnet Hospital.

The designation makes YH one of only 300 such facilities amongst the nation's 6,000 hospitals and places it in the top 5 percentile of hospitals providing outstanding care quality.

Dr. Gail Wolf, chair of the Magnet Commission, provided this outstanding news to Valerie Hardy-Sprenkle, VP Patient Care Services via conference call before a room filled with members of the York Hospital Nursing Leadership Team, members of the Office of the President, and interdepartmental staff magnet champions. Dr. Wolf indicated that the designation was effective immediately and would remain so for the following 4 years.

York Hospital has had a legacy of excellence and service to the communities of York and Adams counties for many, many years as a Solucient Top 100 Hospital. The Magnet designation from the American Nurses Credentialing Center is another external validation of this excellence and is seen as representative of the outstanding levels of quality care provided by all departments and members of the healthcare team. The designation is reflective of the Healthcare focus YH provides to its patients and

families, the strength of professional nursing practice and the outstanding clinical outcomes accomplished through collaboration and excellence in nursing care.

- **New "Performance Officer" Could Boost Visibility, Impact of Quality, ASQ President Says**

Hopefully President Obama's new chief performance officer will have truly "transformative" authority, ASQ President Roberto Saco says.

If the new CPO position within the federal Office of Management and Budget is limited to simple budgetary oversight, "it may mean better control of government expenditures, which would be no small feat, but nothing really groundbreaking," says Saco.

"On the other hand, if the role focuses on how work actually gets done or not done in government, the potential is transformational."

In January, Obama announced that Nancy Killefer, a senior executive at the consulting firm McKinsey & Company, would be the first person appointed to the new CPO position. Killefer is officially charged with "finding government efficiencies."

A CPO willing, able, and empowered to step beyond fiscal oversight and into the realm of process improvement could have profound effects on government efficiency, healthcare, education and other issues Obama has deemed key to rebuilding the U.S. economy, Saco says.

And a new emphasis on quality would mean "abundant opportunity" for ASQ members to help the country bring about real change. "One of ASQ's strengths is that we encompass a wide range of sectors and industries, so in essence ASQ members can play a part in just about any aspect of the president's call to action," he says.

Listening to Obama's inaugural address, he says, "the call to service was loud and clear."

While the U.S. economy is clearly in trouble, "great crises pose great opportunities for the right leader," Saco says. "I'm optimistic President Obama will seize the moment and help us reformulate America's place in the world. The possibilities are endless for those willing to reinvent themselves."

- **Engineering Image Problem Could Fuel Shortage**

ASQ Survey: Career Not on Radar for Kids or Parents

**Milwaukee, Wis., Jan. 22, 2009** — When it comes to kids' dream jobs, engineering has its own problem to solve. An overwhelming 85% of kids[1] say that they are not interested in a future engineering career for a variety of reasons, according to recent surveys of youth and adults conducted by Harris Interactive® on behalf of ASQ (American Society for Quality).

Survey results indicate the top reasons why kids may not be interested in pursuing engineering:

- Kids don't know much about engineering (44%).
- Kids prefer a more exciting career than engineering (30%).
- They don't feel confident enough in their math or science skills (21%) to be good at it— despite the fact that the largest number of kids ranked math (22%) and science (17%) as their favorite subjects.

Findings from the adult survey on this topic show:

- Only 20% of parents[2] have encouraged/will encourage their child/children to consider an engineering career.
- The vast majority of parents (97%) said they believe that knowledge of math and science will help their children have a successful career.

The ASQ survey among youth ages 8-17 as well as among parents aimed to provide a better understanding about the perceptions of selecting an engineering career in light of a troubling shortage of U.S. engineers, which will reach 70,000 by 2010 based on an estimate by the National Science Foundation.

**Other survey findings:**

The survey also found the following gender differences in career interests and intent:

- More girls say their parents are likely to encourage them to become an actress (21%) than an engineer (10%). Other careers that parents encouraged girls to think about include doctor (33%), lawyer (25%), teacher (31%), veterinarian (23%), nurse (20%) and businessperson (17%).
- Boys (24%) are significantly more likely than girls (5%) to say they are interested in an engineering career.
- 31% of boys vs. 10% of girls say their parents have encouraged them to think about an engineering career.

"It's clear that there is a low level of interest and knowledge about engineering careers for both parents and children," said Maurice Ghysels, chair of ASQ's K-12 Education Advisory Committee. "Educators and engineers need to work more closely together to get students excited about the profession and spotlight interesting role models."
